### ARES News

The following was issued on Christmas Day by Bill Morine, N2COP, NC Section Manager:

“NOTE: Tom Brown, N4TAB, the North Carolina Section Emergency Coordinator (SEC) sent the following message shortly after 6 PM local time Saturday evening to all Amateur Radio Emergency Services (ARES) county Emergency Coordinators (ECs). While no widespread ARES activation is expected, operators are advised to monitor their local or regional SKYWARN and ARES repeaters, and the Tar Heel Emergency Net (THEN) on 3923 KHz in case the storm gets worse. Further email updates will be sent if justified.”

(This was followed by a message from Tom Brown, N4TAB, NC Sections Emergency Coordinator)

“All NC counties NC are under Winter Storm warnings. Every county is expected to receive snow.

Very hazardous driving conditions are expected through Monday. There is no anticipated infrastructure damage and a wide ARES activation is not expected.

Counties that employ ARES in shelters may receive requests for support.

At least one Central Branch county is on standby to support a county EOC on Sunday.

NCEM Branch RCCs are operating on standby, with personnel monitoring from their home offices.

A formal declaration of a State of Emergency will probably be issued tonight.

NC ARES personnel are participating in NCEM statewide conference calls and monitoring Web EOC.

While there is no expectation of activation, please remain vigilant and informed and in-touch with your served agencies. If an activation occurs in your jurisdiction, please inform your DEC and/or ASEC of the nature and scope of the activation and your plans and anticipated needs.

If you don't have a current list of your NC ARES leadership colleagues and contact info, log-in to the nc-ares.org database and make a spreadsheet.

Similarly, go to <www.ncarrl.org/ares> and record information about your surrounding jurisdictions and contact information.

This is a good time to review your ICS-204, ICS-205 and ICS-216 forms for accuracy. Be sure that everyone in your jurisdiction has a current copy.

Merry Christmas and stay safe.”

#### FIELD DAY RESULTS – Congratulations to the 69

clubs and individuals who submitted Field Day logs from the Tar Heel state. The overall score total winner was the combined location of the Orange County and Durham FM radio clubs. They ran a 10AB configuration and scored 13,445 points. Close behind running 8A was RARS, the Raleigh Amateur Radio Society, as W4DW with 12,802. Other notable performers were the Cary Amateur Radio Society (CARS) as K4M with 8,852 points running 2A, and the NC Contesters running 3A under NR3X with 9,638 points. Thanks to all who participated. **WELCOME NEW CLUB** – A hearty hello to the Haywood County Amateur Radio Club, which became an ARRL affiliated club on November 11th, and has 31 members. They meet on the 2nd Tuesday of each month at the Haywood EOC in Waynesville, about 25 miles west of Asheville. **ANTENNA LAW SETBACK** – Cleveland County commissioners voted for an ordinance which challenges the intent of the 2007 North Carolina state antenna law. The good news: no height restrictions are in the ordinance and Amateur Radio antennas are now allowed in all zoning districts. The bad news: many antennas can now possibly be defined as a “tower” and subject to a \$200. permit fee. The state law contains the phrase “reasonable accommodation” which is not defined. This is the first municipal ordinance in North Carolina since the state antenna law went into effect and which could require many common antennas, especially guyed verticals, to have a permit. Cleveland County Hams and ARRL are assessing options in addressing this issue. If your city or county is looking to enact an antenna ordinance, please take advantage of ARRL's extensive resources and experience in this arena.

**IS YOUR C.W. RUSTY?** – There's an old joke among musicians: Q: How do you get to Carnegie Hall? A: Practice, practice, practice. The upcoming winter months are the perfect time to enjoy a warm beverage and practice your CW skills. And in the Carolinas, there's no better way to watch your skills improve than to check into the Carolinas Slow Net (CSN) held every night at 8:00 PM local time on 3571 KHz. This friendly net welcomes newcomers and will really help your speed to improve.

### SPECIAL NOTICE TO THOSE HAMS OVER AGE 70 ½

My day job for the past 18 years has been a financial planner, so I was glad to read that Congress extended provisions which permit people over age 70 ½ to make tax free contributions from their IRAs to charities. The receiving entity has to be an IRS recognized non-profit organization, such as ARRL and possibly your local club if it is incorporated. Before you do anything, consult your tax preparer or financial adviser to see if this method of giving is in your best interest. ### NCVEC Releases New General Class Question Pool

The Question Pool Committee (QPC) of the National Conference of Volunteer Examiner Coordinators (NCVEC) released the new General class (Element 3) question pool on Tuesday, December 7. This new question pool -- including graphics and diagrams -- will become effective for all General class examinations administered on or after July 1, 2011; it will remain valid until June 30, 2015. The current General question pool that became effective July 1, 2007 will expire June 30, 2011. The new General pool contains 457 questions, from which 35 are selected for an Element 3 examination.

The current Technician class question pool that was effective July 1, 2010 is valid through June 30, 2014. The current Amateur Extra class pool that was effective July 1, 2008 is valid until June 30, 2012.
