Cell Phone Ban Bill

The North Carolina Senate Commerce Committee added language to Senate Bill S12 that would specifically exempt Amateur Radio operation from a proposed ban on cell phone use while driving in the state. NC Senator William Purcell added the language at the request of Bob Conder K4RLC, ARRL NC Section State Government Liaison (SGL). After aspects of the bill were discussed and amendments unrelated to Amateur Radio were adopted, the bill was tabled until a future date.

As currently written, the bill states that "no person shall operate a motor vehicle on a public street or highway while using a mobile telephone* or any additional technology** associated with a mobile telephone while the vehicle is in motion." The amended language includes "This term does not include two-way mobile radio transmitters or receivers used by licensees of the Federal Communications Commission in the Amateur Radio Service." The language of the amendment was supplied by the ARRL.

According to Sen. Purcell, a co-sponsor, Amateur Radio operation was never targeted by the bill, and would have been exempt anyway because it isn't covered under the definition of "mobile telephone." Conder requested the specific exemption, pointing out that Amateur Radio is not well understood by all law enforcement officers, so officers who don't recognize the difference between a ham radio and a mobile phone might cite hams operating mobile.

Media stories point out that similar bills have been proposed over the past several years, and have always been defeated or died in committee. That fate is also expected for this bill, although other states have enacted bans, and last year North Carolina banned cell phone use for drivers under the age of 18. Conder said even if this bill fails, having the Amateur Radio exemption is good because the language will likely be adopted automatically when the bill resurfaces next year.

Two others bills (SB22 and H9) that target "texting while driving" are currently working their way through the NC legislature. These

don't appear to pose any threat to mobile Amateur Radio operation. But ARRL NC SGL Bob Conder, K4RLC, will be monitoring the progress of these bills also. From Gary Pearce KN4AQ, ARRL Public Information Officer

Judge Rules in Favor of Amateur



In the Palmdale Antenna Support Structure Case --On Friday, February 6, Los Angeles Superior Court Judge David Yaffe

issued a ruling in favor of Alec Zubarau, WB6X, of Palmdale, California, in Zubarau's case against the City of Palmdale. Last year, after Zubarau received a valid building permit from the City to erect an antenna support structure, the City of Palmdale revoked Zubarau's building permit after he had erected the tower. According to Zubarau's attorney, Len Shaffer, WA6QHD, the Court's ruling invalidates the actions of the City in revoking Zubarau's permit and requires the City to allow him to replace the tower. "Zubarau's case has drawn nationwide attention and financial support from the ARRL, Amateur Radio clubs and individual Amateur Radio operators from around the country," said ARRL Southwestern Division Vice Director Marty Woll, N6VI. "Although this ruling does not directly address the City's proposed zoning ordinance amendment, based on the Court's language, it should provide considerable support for those hams attempting to negotiate a more reasonable provision allowing antenna support structures in the Palmdale City Code." ARRL
