NC Wireless Telephone Law E-Mail...is a hoax. No NC legislation to limit adult driver's behavior (including operation of cell phones) is/was enacted. No limit on adult use of any communication device while driving has passed the NC Legislature up to now. The e-mail claims the ban on driver phone use would take effect July 1, with fines incurred for transgressions. Wireless devices, such as those using Bluetooth technology, would be allowed.

The legal codes referenced in the e-mail are identical to those that will go into effect in California on July 1.

Mecklenburg Democratic Rep. Charlie Dannelly proposed such a ban in the North Carolina Senate in April 2007, but it was not passed.

Matt Thompson, manager of public relations at the Safety and Health Council of North Carolina, a nonprofit that educates the public about safety, urged driver safety even in the absence of a cell phone ban.

"It's not just a matter of handheld and not handheld. It's a matter of focus," Thompson said.

North Carolina currently prohibits cell phone use only for drivers younger than 18 and school bus drivers while on the road.

Vanity Call Sign Fees

The FCC released a Notice of Proposed Rulemaking and Order (NPRM) on May 8 seeking to raise fees for Amateur Radio vanity call signs. Currently, a vanity call sign costs \$11.70 and is good for 10 years; the new fee, if the FCC plan goes through, will go up to \$12.30 for 10 years, an increase of \$.60. Instructions on how to comment on this NPRM are available on the FCC Web site at, <http://www.fcc.gov/cgb/consumerfacts/howtocomment.html>. Holders of vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign regulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commission. Applicants can obtain an FRN by going to the ULS site at, <http://wireless.fcc.gov/uls>, and clicking on the "New Users Register" link. You must supply your Social Security Number to obtain an FRN.

STATE ARES MEETING NOTES

Thanks to Bob DeWitt, K4RLD, for these notes from our Section ARES meeting, held May 3 at the state EOC in Raleigh.

ARRL Simulated Emergency Test (SET)

Changes are coming, with more emphasis on a regional rather than section exercise. ARRL is also considering a national NTS exercise.

Broadband Over Power Lines (BLP) issue has lost steam. It was too expensive for power companies to implement. ARRL's lawsuit against the FCC: If "broadband over power lines" isn't dead, it's certainly in intensive care!

Special license plate fees... Many of you will remember that Joe W1FAI mentioned at the January AREA 13 meeting that organizations that have special license plates receive \$10.00 each time that those plates are renewed. There are nearly 3,400 amateur radio plates issued each year so we are talking about \$34,000 each year that could be used for the public service aspects of Amateur Radio. According to Tim (N4IB) the Section Manager, we will have to form some type of corporation or foundation before we can proceed. Tim Slay, N4IB, is pursuing non-profit incorporation for North Carolina ARES. This would give us the option of providing liability insurance for ARES activities and allow ARES to own assets.

State ARES Objectives for 2008: Increase membership, fill vacant positions, train all ARES members in ICS courses (IS-800 is now required in many areas), implement statewide digital communications, implement Training Officer position, increase activity on the Tarheel Emergency Net and obtain a list of relief operators that are self contained. The Western Branch was singled out for both their training efforts and the monthly EC reports. Bernie recognized Cleveland County for the aggressive manner in which they have initiated Cleveland County ARES and SKYWARN. June - W4LPL, Ben - KM4C, and Cleveland County EC Susan - K4ZXN attended the meeting. They were the only county represented from AREA 13 and the Western Branch.

The **State Digital Plan** was discussed... Orders have been placed for a PTC II for the Eastern Branch Office, the State EOC, and the Western Branch Office. There is still much to do on this topic.

ICS-213 message form... This is a message form that has been developed. It is a form that has space at the top for the outgoing message, and a place at the bottom for the response coming back to the sender as well as other information. It was observed that there was no message number or a "check" count. The question was, if a large volume of traffic has been sent out, when a reply is received, how can it be determined to which message the reply should be attached? This will be reviewed and an improved version placed on the NC ARES webpage www.ncarrl.org/ares. There was discussion about "incoming" health and welfare traffic during an emergency. It seemed to be the consensus that the local EC should be the one to decide when the resources are available to handle "incoming" traffic of that sort. Bernie asked that the ECs and DECs do more to **promote SKYWARN** around the state. And, if the local SKYWARN effort is under the control of ARES, any SKYWARN activation should be listed under "Emergency Operations" on the monthly EC report. Paul KD4OZI the Western Branch ASEC asked about having these meetings in the Western Branch from time to time. Bernie said that he understands that it is a hardship on Western Branch counties to attend because of the distances involved and that we will be having a second meeting later in the year that would be held in the Western Branch. American Red Cross - Responds to ARRL Concerns Regarding Background Checks. In November 2007, ARRL President Joel Harrison, W5ZN, wrote to the American Red Cross (ARC) regarding concerns voiced by ARRL volunteers. In 2006, the Red Cross stated it would implement background checks that included,

among other things, a credit check and a "mode of living" check for its staff and volunteers, including ARES volunteers providing services to the Red Cross during disasters. ARRL saw these portions of the background check as unneeded and inappropriate for ARES service.

In a letter dated May 8 of this year, Armond T. Mascelli, ARC Vice President for Disaster Response Services replied to President Harrison: "I can now report back to you that [these] actions have been completed and changes have been instituted which I trust resolves the concerns detailed in your letter. This effort took considerably more time and attention than originally envisioned, but I believe the results will now benefit our respective organizations.

"A new background consent form now [is] to be used by all Red Cross chapters for ARRL members and other partner organizations. The form and related process is limited to the name and social security number verification of the individual, and a criminal background check"...

ARRL Emergency Preparedness and Response Manager Dennis Dura, K2DCD, announced the resolution at the ARRL ARES forum at the Dayton Hamvention® and received hearty applause.

"We are very pleased that the American Red Cross has addressed some of the issues that we raised regarding their background investigations and that we can move forward in a relationship that has existed for a long, long time," Harrison said. "The American Red Cross and the ARRL have shared a productive relationship for many years which has been of benefit to both the organizations and to the public. We are glad that throughout the past months we have been able to negotiate the issues that we had and have finally come to a resolution." What's Next?

With the background check issue apparently resolved, the ARRL will be working with the ARC in the negotiation and creation of a draft for a new Memorandum of Understanding (MOU) or similar document to replace the one which expired last year; Dura and Keith

Robertory of the ARC will be leading the effort. When complete, the draft of the MOU will be presented to the leadership of both organizations for approval.

"The ARRL is very pleased that the American Red Cross has responded appropriately to our concerns about the background check issue," said ARRL Chief Executive Officer David Sumner, K1ZZ. "We believe it now will be possible to go forward to negotiate a statement of understanding between the two organizations. We look forward to renewing and expanding the relationship with the Red Cross."

KB4C Award

I am asking for nominations for the KB4C award for outstanding contributions to emergency and public service communications in Western North Carolina.

This award is to honor an area amateur who is active in serving the community through amateur radio. Previous recipients of this award were: K4AIF, WD4CNZ, K7DXF, K4YYR, KF4MRH, AE4HJ, KC4QPR, N2JLE, WA4GTT, K4BNP, KF4ZDS, W4DK, and AF4HX.

The award is named in honor of Miriam Smith, KB4C who became a silent key in July 1995. She was one of those amateur radio operators who felt more deeply about her license and commitment to emergency communications than many of the "hams" in the area. She held an extra class license, received the A-1 Operators award and was ARES Emergency Coordinator/Races radio Officer for Buncombe County in the 1970's and was responsible for the earliest draft of the Buncombe County Emergency Response Plan, parts of which are still used today.

The award will be selected from nominations submitted from anyone in Areas 14 and 15 (the Western North Carolina Counties -old Area F). A panel selected by the Area 14 DEC will make the selection.

Criteria for this award will be any active licensed amateur within areas 14 and 15 who has demonstrated a long term commitment to emergency and public service communications through the ARES/RACES programs. The recipient does not have to belong to any specific group. They must simply demonstrate an active commitment to the job we are asked to do.

The Award will be presented at the WCARS Hamfest on July 26th, 2008.

Silent Keys

With deep regret WCARS records the loss of fellow amateurs

Ronald A. Parise. PhD - WA4SIR. Dr Parise passed away Friday May 9, 2008 after a very long and courageous battle with cancer. He was 57. Parise flew as a payload specialist on two space shuttle missions. These two missions, ASTRO-1 and ASTRO-2

respectively, carried out ultraviolet and x-ray astronomical observations, logging more than 614 hours and 10.6 million miles in space. Chairman Frank H. Bauer, KA3HDO, said Parise's personal contributions to these two missions provided scientists with "an unprecedented view of our universe, expanding our understanding of the birth, life and death of stars and galaxies."

First licensed when he was 11, Parise kept Amateur Radio at the forefront of everything he did, including his operations from space. During his two shuttle flights, he spoke with hundreds of hams on the ground. He was instrumental in guiding the development of a simple ham radio system that could be used in multiple configurations on the space shuttle; as a result, his first flight on Columbia ushered in what Bauer called the "frequent flyer era" of the Shuttle Amateur Radio Experiment (SAREX) payload.

"His flight pioneered the telebridge ground station concept to enable more schools to talk to shuttle crew members despite time and orbit constraints," Bauer said. Ron was also the ultimate ham radio operator -- in space and on the ground."



L. B. Cebik, W4RNL, ARRL Technical Adviser and antenna authority, passed away in late April of natural causes. He was 68. Many hams knew Cebik, an ARRL Life Member, for the numerous

articles he wrote on antennas and antenna modeling.

Larry Wolfgang, WR1B, QEX Editor, called Cebik "probably the most widely published and often read author of Amateur Radio antenna articles ever to write on the subject." Cebik lived in Knoxville, Tennessee and wrote more than a dozen books on antennas for both the beginner and the advanced student. A teacher for more than 30 years, Cebik was retired, but served as Professor Emeritus of philosophy at the University of Tennessee, Knoxville. Cebik served his country in the US Air Force from 1957-1961, specializing in air traffic control.

One of Cebik's last articles for QST, "A New Spin on the Big Wheel," appeared in the March 2008 issue. The article, co-written with Bob Cerreto, WA1FXT, looked at a three dipole array for 2 meters.

Cebik's web site, www.cebik.com, is a virtual treasure trove to anyone interested in antennas. His Web site also contains information on antenna modeling. Wolfgang remembered Cebik, saying, "L. B. was an ARRL Technical Advisor, with expertise in antenna modeling and design. I learned that I could count on L. B. to offer clear, concise comments on any submitted article dealing with antennas." "L. B. leaves a legacy of friendly advice and Amateur Radio wisdom. I will miss him as a friend and as an advisor." Edited from ARRL HQ

receives OSCAR Designation... Bill Tynan, W3XO, announced that Amateur Radio satellite Delfi C-3 has been issued an OSCAR number: Delfi-C3 OSCAR-64 or Dutch OSCAR-64. The shortened version of either of these two designations is DO-64.

Developed by a team of some 60 students and facility members from various polytechnic schools in The Netherlands, Delfi C-3 was successfully launched April, 28, 2008 from India aboard a Polar launch vehicle and was successfully commissioned. Delfi C-3 currently transmits telemetry on the 2-meter amateur band, and uplink is on the 70 cm band. "AMSAT-NA is pleased to welcome DO-64 into the family of Amateur Radio satellites," Tynan said. "We are hopeful that it will fulfill its intended mission of furthering education and increasing interest in the Amateur Radio space program. We congratulate all of those responsible for designing, building, testing and launching this new Amateur Radio satellite and look forward to its long and productive life."

FCC's Hollingsworth Set to Retire in

July (May 20, 2008) -- Special Counsel in the FCC Spectrum Enforcement Division Riley Hollingsworth has announced plans to retire from the FCC later this year. "My intention," Hollingsworth told the ARRL, "is to head out in July, assuming the results of the second round of the PAVE PAWS/440 repeater monitoring in California present no complications. It has been a privilege to work with and for the Amateur Radio licensees and the land mobile frequency coordinators. I am extremely fortunate to work for two wonderful groups of people: Those at headquarters in the Enforcement Bureau, and for the Amateur Radio operators." Hollingsworth had planned to retire earlier this year, but changed his mind, saying, "There [were] several issues on the table that I want[ed] to continue to work through with the amateur community."
