Senate Introduces Companion Bill to HR 2160

On October 6th, Senator Joe Lieberman (D-CT), along with Senator Susan Collins (R-ME), introduced Senate Bill 1755, The Amateur Radio Emergency Communications Enhancement Act of 2009, similar to HR 2160 - also called The Amateur Radio Emergency Communications Enhancement Act of 2009... Right now, S 1755 has been read twice in the Senate chamber and referred to that body's Committee on Homeland Security and Governmental Affairs. HR 2160 -- now with 27 sponsors -- is in the House Committee on Energy and Commerce. SB QST ARL ARLB031 ARRL



ARRL to Participate in the Combined Federal Campaign (Oct 21, 2009) -

- For the eighth year

running, the US Office of Personnel Management has designated the ARRL to participate in the 2009 Combined Federal Campaign (CFC). In the past, this campaign for federal government civilian employees, US Postal Service workers and members of the military has generated more than \$160,000 for ARRL programs since it first became an option for giving by federal employees to the League. The CFC provides an easy way to support ARRL's effort to represent its members and all radio amateurs. Similar to the United Way, the CFC encourages individuals to pledge by payroll deduction to non-profit organizations of their choice. The ARRL encourages eligible radio amateurs to consider the League when designating campaign recipients. Payroll deduction through the CFC is an easy way for participants to support ARRL over and above their annual membership. Such contributions support programs that are not funded by member dues, enriching ARRL's ability to serve its members and all of Amateur Radio. Those wishing to select the ARRL to receive all or part of their payroll deductions should designate organization 10099 when completing their CFC donor forms. Donations to ARRL can be designated for Diamond Club contributions, the ARRL Spectrum Defense Fund or the ARRL Education & Technology Program. Donors may also make unrestricted contributions to the League. One important note: Since the CFC does not provide the ARRL with the names of individual donors, the ARRL Development Office would appreciate a copy of the donor form to ensure that each contribution is applied according to the donor's wishes and the contribution or pledge can be properly acknowledged. New Israeli Battery

A new kind of portable electrochemical battery that can produce thousands of hours of power - and soon replace the expensive regular or rechargeable batteries in hearing aids and sensors and eventually in cellphones, laptop computers and even electric cars - has been developed at Haifa's Technion-Israel Institute of Technology...

This new battery can provide thousands of hours of power. The unique battery is based on silicon as a fuel that reverts to its original sand. The battery can also be left on the shelf for years and inserted into a device to provide immediate power...

The work was conducted with a grant from the US-Israel Binational Science Foundation, and an article on the battery was just published in the journal Electrochemistry Communications...

October 1st Minutes...Bob - WD4CNZ

The October meeting of WCARS was called to order at 7:29pm with President Dean Blair presiding. He then invited the group to join him in reciting the Pledge of Allegience. Each attendee was then asked to introduce themselves with callsign and home QTH. As the Minutes were published in the latest issue of SMOKETEST, a motion was made, seconded, and voted to accept those as published in lieu of reading the Minutes. The Treasurer's report was presented with a balance after fees and expenses of \$10,123.64. The report was accepted with thanks.

Dean commented about the NC Mountain State Fair event and his observations of the reactions of interested visitors. The event was a cooperative effort with the Blue Ridge ARC (Hendersonville). The ILRP link was of particular interest by visitors. Ideas for next year's event were exchanged.

Norman N4NH spoke about planning new ham classes to start Jan 19, 2010. He asked everyone to pass the word and keep him informed of the numbers who may attend so that he can plan the needed facility size.

Dean showed pictures of the Blue Ridge Bonanza Special Event with Elwood Miles providing commentary and explained the problems with the rain cover. Dean made recommendations of what to consider for future operations as only 43 QSO's were made this year with weather as a factor for low numbers.

SET will be Oct 3 from 0800-1200 with the activation of the Tar Heel Emergency Net. The scenario was presented on the evening of Oct 2. Everyone was invited to participate with particular attention of using emergency power sources where possible.

The next SKYWARN class will start soon. Interested persons are asked to contact Duke W4DK@arrl.net if you want to attend.

It was voted that the Tentec Omni owned by WCARS be traded for a Yaesu unit to go into the MOE Van.

The Shut-In Run is set for Nov. 7. T-shirt sizes and volunteer names were recorded. Nominations for club officers for 2010 were opened. The By-Laws state that persons being nominated must give their permission to be nominated. The following shows the status at this time:

The Program for the evening was presented by Dean about the LOGBOOK OF THE WORLD (LoTW). (this program is availabe free of charge from ARRL). Dean explained the basics of the format, advantages, security and how the program differs from other programs. He recommended this program for all to use.

The 50-50 drawing was won by KI4FPC who then donated the money to the WCARS Treasury--thank you!

The doorprize (mug) was won by Keith Galyen.

The meeting was adjourned at 8:40pm with refreshments following.

State ARES Meeting

The ARES meeting held October 17, was a huge success. Thanks to Paul, KD40ZI and Michelle, KD4YTU for hosting the event. There was extensive discussion of training requirements for ARES members. Radio amateurs and other volunteers working with emergency management must to be familiar with NIMS; FEMA has developed an online training program. A poll of other section managers conducted by N4IB indicated that only a couple of sections have made NIMS training mandatory for ARES membership. Some sections have instituted two levels of members in ARES - "active" and "reserve" - to differentiate between trained and untrained members. Most sections still have no training requirements, although everyone is encouraged to complete NIMS training. The consensus of the group at our meeting was to establish two levels of ARES membership. One tier would be for amateurs with the NIMS training required by state emergency management. "Trained" members would be the first deployed and in most cases the only amateurs sent to EOC's, shelters and other served agency locations, and the only members eligible for a field assignment outside their local jurisdiction. ARES "untrained" members would be used for support assignments, such as serving as liaison stations, and encouraged to become fully trained as soon as possible. NC ARRL Former Section Manager John Covington, W4CC, presented a draft of his study on Packet Radio and North Carolina ARES. After further revision, his paper will be posted at www.ncarrl.org.

Assistant SEC Tom Brown, N4TAB, discussed the Winlink system installed at the branch EOC's and the big success we had using Winlink during the earthquake drill in June. The meeting included discussion on the ICS-213 message form and ARES implementation. State emergency management requires its use. A modified ICS-213 form is used for handling messages on the Tarheel Emergency Net. An "operator's notes" section can be added to include pertinent information. From NC ARRL

Radio Amateurs Killed in Plane Crash En Route to CQWW Phone Contest

In the early AM on October 21 -- a twin-engine plane carrying four Amateur Radio operators crashed into the woods, 250 yards from the end of the runway in Jedburg, South Carolina, 20 miles northwest of Charleston. The plane -piloted by Peter Radding, W2GJ -- carried Ed Steeble, K3IXD, Dallas Carter, W3PP, and Randy Hargenrader, K4QO. The four men were on their way to the Bahamas to operate in this weekend's CQ World Wide Phone Contest as C6APR, competing in the Multi/2 category... "How quickly can a joyous event -- setting off with close friends in anticipation of a weekend of intense radio activity -- turn to unfathomable tragedy," said ARRL Chief Executive Officer David Sumner, K1ZZ. "As we mourn the loss of these four well-known members of our global Amateur Radio community, our hearts go out to their families...'
